Based on the Lol, IEA, Statement of Compliance and Self Study Report submitted by the University and subsequent report of Peer Review Team, the National Agricultural Education Accreditation Board of ICAR in its XXIV meeting held on 29th July, 2019, granted accreditation to the School of Agriculture, ITM University, Gwalior and its B.Sc. (Hons.) Agriculture programme for a period of five years i.e. from 20th July 2019 to 28th July 2024.

The School of Agriculture has scored overall a Score of 2.75.

The University is thus required to address the observations of the Board in a time bound manner. As per the Board decision, a Mid-term review will be conducted after 2.5 years.
